Dear Skaters and Parents:

Welcome to the 2023-2024 skating season. Attached you will find a Pittsburgh FSC membership form for 2023-24. Please read everything carefully and keep in mind that you need to be a current member in good standing in order to test, to compete in any USFS competitions and to participate in any sanctioned shows or exhibitions. Please make sure you read and understand the club ice package/walk-on fee.

Your club membership begins July 1, 2023 and ends June 30, 2024. ALL forms must be completely filled out and your membership fee paid in full. Please remember that you CANNOT test or compete or paticipate in any sanctioned shows or exhibitions until your membership is current.

In order for the Pittsburgh Figure Skating Club to be able to provide services to its members (tests, competitions, skating sessions, banquets etc.), we must rely heavily upon the willingness of the membership to help provide the man/woman power necessary to help complete the various tasks involved. Anyone in the club who is able to help is welcome and their efforts are needed. Without a larger base of volunteers willing to help, we may not be able to continue providing the same level of services we have in the past.

In addition to membership fees, and in order to test and compete at USFS sanctioned events, and to be a member in good standing, skating members (Full Member Home Club; Introductory Members and Non-Skating Adults) are required to volunteer at least 6 HOURS – per member – at a Pittsburgh FSC event. Volunteer hours can be completed by the skating member or a family member of the skater. Pittsburgh FSC events include: Ice monitor during club ice sessions; Basic Skills Learn-to-Skate at Schenley Park each winter; Shamrock Skate; Skate Pittsburgh; test sessions; club's annual banquet; serving on a committee or Board of Directors. Completion of the work hours is required to remain a member in good standing. FOOD DONATIONS FOR TEST SESSIONS, COMPETITIONS, ETC. WILL NOT BE ACCEPTED TO COUNT TOWARD VOLUNTEER HOURS. Should you choose not to complete the required work hours, we will require an additional payment of \$120.00 for unfulfilled hours. However, any hours you do volunteer will be counted and if the full 6 hours is not completed, the fee will be pro-rated at \$20.00 per hour. For example, if you only complete 4 hours of vounteer time, you will be assessed an additional \$80.00. Members not completing work hours or making payment for them will not be in good standing and will be ineligible to test or compete. Completion of your hours and/or progress toward that goal will be evaluated at the end of December to determine if the additional payment of \$120 or pro-rated amount will be required. At least half (3 hours) of the volunteer hours should be completed between July 1 and December 31, 2023. We really need the help more than the money.

All coaches, except those under age 18 or Basic Skills instructors engaged only in group lessons, must also be USFS members and are required to register with US Figure Skating to verify liability insurance and provide information for a required background check. Registration is necessary to participate in all non-qualifying and qualifying competitions and test sessions.

Also, the club will be sending any club information, news, volunteer sign-ups, etc., via email. Please make sure you list your email address.

U.S. Figure Skating Parents Code of Conduct

Codes of Conduct give everyone a guide to what is expected of us if we are part of an organization, participating in a sport, or as spectators at our child's events.

Preamble: The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and six core principles: respect, responsibility, fairness, caring, trustworthiness and good citizenship. The highest potential of sports is achieved when competition reflects these "six pillars of character" (Arizona Sports Summit Accord)

By signing below I hereby agree that:

- 1. I will encourage good sportsmanship by demonstrating positive support for all skaters, coaches and officials at every practice session, competition and test session.
- 2. I will place the emotional and physical well being of my child ahead of my personal desire to win.
- 3. I will encourage my child to skate in a safe and healthy environment.
- 4. I will inform my child's coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
- 5. I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the results of a competitive event.
- 6. I will never ridicule or yell at my child or other participant for making a mistake or blame my child's teammates for placement in a competition.
- 7. I will do my best to make skating fun and will remember that my child participates in sports for his/her own enjoyment and satisfaction not mine.
- 8. I will ask my child to treat other skaters, coaches, fans, and officials with respect, regardless of race, creed, color, sexual orientation or ability.
- 9. I will applaud a good effort in both victory and defeat emphasizing the positive accomplishments and learning from the mistakes.
- 10. I will teach my child to resolve conflicts without resorting to hostility or violence.
- 11. I will be a positive role model for my child and other skaters.
- 12. I will demand a figure skating environment for my child that is free of drug or alcohol abuse and agree that I will not use or provide to a third party any drug proscribed by applicable federal, state, or municipal law.
- 13. I will not assist or condone any competing athlete's use of a drug banned by the International Olympic Committee, International Skating Union, United States Olympic Committee, or U.S. Figure Skating, or, in case of athletes, to use such drugs or refuse to submit to properly conducted drug tests administered by one of these organizations.
- 14. I will not provide alcohol to, or condone the use of alcohol by minors, abuse alcohol in the presence of athlete members, or at U.S. Figure Skating activities or, in the case of athletes, consume alcoholic beverages while a minor.
- 15. I will encourage my child's coach to continue their education and training through programs offered by U.S. Figure Skating, the Professional Skaters Association and other accredited organizations.
- 16. I will respect my child's coach and refrain from coaching my child or other skaters during competitions and practices because it may conflict with the coach's plan or strategies.
- 17. I will respect the decisions of officials and their authority during competitions and test sessions and teach my child to do likewise.
- 18. I will show appreciation and recognize the importance of volunteers and club officials.
- 19. I will study the rules of the U.S. Figure Skating and teach my child accordingly so that we have an understanding and appreciation of the rules of competition and membership.
- 20. I will support all the opponents in my child's competition and respect the rights of all skaters to participate.

I recognize that my participation in all activities hosted, supported, sponsored or engaged in by U.S. Figure Skating, including but not limited to competitions, exhibitions and training camps, is an honor and privilege that carries certain responsibilities. I agree to fully abide by the rules and guidelines set forth by U.S. Figure Skating or its properly designated agents. As a precondition to participation in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating, I will adhere to the following tenets in good faith:

- A. I will exhibit the highest standards of fairness, ethical behavior and genuine good sportsmanship in all of my relations with others.
- B. I will not damage public or private property. I understand that I may be held financially responsible for damage deemed to be wantonly or willfully executed on my part, and that I may be subject to disciplinary action by U.S. Figure Skating.
- C. I will not use or possess illegal drugs, and I will not engage in criminal activity. I understand that, if I am found to use or possess illegal drugs, or if I am found to engage in any criminal activity during any activity hosted, supported, sponsored or engaged in by U.S. Figure Skating, I may be subject to criminal penalties as well as penalties imposed by U.S. Figure Skating.
- D. I will adhere to the rules of U.S. Figure Skating and the host organization at all activities hosted, supported, sponsored or engaged in by U.S. Figure Skating.
- E. I will comply with all applicable anti-doping rules including, but not limited to, ISU and USADA anti-doping rules.
- F. I will conduct myself in a manner not detrimental to the welfare of figure skating. I understand that my actions reflect on U.S. Figure Skating and the sport of figure skating both positively and negatively. I understand that if my acts, statements, or conduct are considered detrimental to the welfare of figure skating by the appropriate authority, I may be subject to penalties imposed by U.S. Figure Skating pursuant to GR 1.04.
- G. I understand that the penalties that may be imposed may include, but are not limited to, loss of future international selections, loss of financial support from U.S. Figure Skating and its Memorial Fund, and loss of participation in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating.
- H. I understand that all disciplinary proceedings will be conducted pursuant to Article XXV, Section 3, of the U.S. Figure Skating bylaws, and that my rights and remedies are derived therefrom.
